The Mall Luton - Community Chest

Terms & conditions

- For the Community Chest fund, selected organisations can apply to receive a portion of up to £2,022, that will be awarded each month.
- The organisation must operate within Luton and Dunstable and the immediate surrounding area.
- For the purposes of the Community Chest run by The Mall Luton, the classification of local organisation covers:
 - a) Constituted Groups
 - b) Incorporated Organisations
 - c) Charities
 - d) Social or Community Enterprise
 - e) Community Interest Companies
- Entries into the Community Chest scheme will take place through the application form on
 The Mall Luton website only www.themall.co.uk/luton. Entries in any other format will not be accepted.
- To enter the Community Chest, the applicant must provide:
 - a) the name of the organisation
 - a short description of the reason for the organisation's application to the Community Chest
 - c) Required value from the £2,022 fund
 - d) a name, email address, postal address and contact telephone number for an appointed representative of the organisation
- A panel from The Mall Luton will choose local organisation(s) from entries received by the
 last day of the previous month to receive the cash prize. The winner(s) will be contacted via
 the contact details on the application form. If the winner(s) cannot be contacted after 5
 working days, another winner will be chosen to receive their allocated portion of the fund.
 The panel's decision is final, and correspondence will not be entered into.
- Selection criteria to be considered as eligible for the fund:
 - All requests must be used to fund organisations or events with a positive impact on the community of Luton, with a specific value of money being spent solely for the stated purposes
 - The fund cannot support applications from profit making organisations, those who
 promote political parties, terrorism or the propagation of religion or conduct of
 worship (religious organisations may apply for funding for non-denominational
 activities demonstrating a wider public benefit), national or regional charities
 (except where funding is targeted locally), retrospective funding, applications where
 more than 50% is spent on staff costs
- The winner will receive their prize via **BACS** within 30 days of their winner photocall. Winners will be required to collect their prize from The Mall Luton, and must be available for publicity purposes, including press photographs.
- Winners consent to having their uploaded photo on the entry form submitted to the press for publicity reasons

- Winners will be required to present photo ID to collect the prize, and the prize money will
 only be paid to the organisation named on the application. Should the beneficiary fail to
 provide requested ID or be found to be fraudulently representing a group, club, charity,
 cause or person, the panel reserve the right to rescind the award.
- Winners will be chosen from all entries received by the last day of the month. Previous
 entries will be discarded each month. Each winning organisation may only win once during
 the Community Chest scheme, which is open from Wednesday 1st June to 30th October 2022.
 The final monthly winners will be announced in November 2022.
- The Mall Luton, its subsidiaries, officers, agents, and employees will not be responsible or liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered in connection with the Promotion or the prizes in any way expect for liability which cannot be excluded by law.
